Explanation of Rates

- Handling (in/out):** Rate is a one-time charge assessed at the time of receipt of goods into the warehouse and includes all charges associated with the standard receiving and shipping of the goods (no other handling of goods required).
- Incoming Storage:** Rate is charged at the time the customer creates the receiving order within the system. Rate may change based on re-measurement of master carton dimensions.
- Monthly Storage:** Rate is assessed at the beginning of each month based on the cubic meter space occupied by the Owner.

<ul style="list-style-type: none"> • Rush Shipment Charge 	<p>For efficiency purposes, orders are normally grouped and picked together, which allows orders to be ready for carrier pickup within 24 hours of receipt of order. In many instances, orders are ready the same day as received, but abnormal volumes and out of sequence picking disrupts the schedule and increases costs. Orders requiring shipping in less than eight (8) working hours from the time of receipt will be subject to a Rush Shipment Charge, unless otherwise agreed upon in writing.</p>
<ul style="list-style-type: none"> • Physical Inventory 	<p>If the client requires the warehouse to take a physical inventory and/or proceed to a reconciliation of inventory records, the client will be charged for the labour at the prevailing hourly rates outlined in the Table of Ancillary Services.</p>
<ul style="list-style-type: none"> • Other Charges 	<p>All other charges are based on our Table of Ancillary Services.</p>
<ul style="list-style-type: none"> • Taxes 	<p>Rates quoted do not include any federal or provincial taxes assessed on our services, which will be added to our invoice(s).</p>
<ul style="list-style-type: none"> • Reconciliation of Inventory Records 	<p>If at any time discrepancies exist between our client's records and the physical inventory, the Warehouse Manager and client shall provide to each other their records of all inventory adjustments from the time of the previous reconciliation to the time of the inventory count in which the discrepancy was found. Warehouse Manager's record shall be presumed to be correct, absent evidence to the contrary. The client has 10 days from the date on the inventory count report to advise the warehouse that a discrepancy exists. If the warehouse receives no such notice, it is assumed that the warehouse inventory count is final and correct.</p>
